**MEMORANDUM OF TRUST :**

1. Name : The name of the trust will be DEVSHEELA TRUST [D.S.T.]
2. Registered Office : The registered office of the trust DEVSHEELA TRUST [D.S.T.] shall be situated at Fazalganj, G. T. Road, P.S.- Sasaram, Distt.- Rohtas.
3. Working Area : All India
4. Aims and Objects :

**[A] Main aims and objects to be pursued by the trust :**

- (i) To promote and undertake and setup educational activities, educational training center and research valuation and extension in furtherance of aims of the trust.
- (ii) To promote and develop health and nutrition for children and upliftment of Ruler women.

**[B] The other objects incidental or ancillary to the attainment of the above objects of the trust :**

- (i) To promote and encourage national integration and communal harmony.
- (ii) To help farmer, labours, rural, artisan and youth in obtaining facilities as required.
- (iii) To promote and develop appropriate rural and tribal technology.
- (iv) To promote and develop non conventional and renewable energy sources.
- (v) To promote cottage industries and village industries, agro industries, irrigation, drinking, forestry, agriculture and animal husbandry.
- (vi) To promote integrated development of the area.
- (vii) To deposit and hand money by the group decision in the supervision of the trust (D.S.T.).
- (viii) To promote and develop the network of the DEVESHEELA TRUST.

- (ix) To promote and develop the preventive measures for health or hygiene for human and animal beings and plant protection, chemical pesticides, fertilizers and new technology.
- (x) To promote the business of or to manage nursing home, polyclinic, physiotherapy center, diagnostic center, processor assembly, traders, importers, exporters, dealers, suppliers, agents of medical, surgical, scientific and engineering equipments and instruments.
- (xi) To establish and maintain dairies, cattle and poultry farms, agricultural farms, piggeries fruit and vegetable gardens, grazing grounds, fish ponds, been hives, forest preservation and all kinds of preservatives for manures, chemicals and such other things as may be deemed necessary or expedient for the trust to undertake.
- (xii) To promote the old age man, women and children careful service, social and educational development.

5. **Ceasation of membership :-** Membership shall cease :-

- (a) On death of member.
- (b) If member becomes of unsound mind.
- (c) If member becomes insolvent as is convicted of a criminal offence involving moral degradation.
- (d) When members resignation is accepted by Chairman/Executive Committee.
- (e) No payment for members for consecutive three years.

6. **Composition of Trust (D.S.T.) :-**

- (a) General body
- (b) Executive Committee

7. **General Body :-**

- (a) The general body will consist of all kinds of members of Trust (D.S.T.)
- (b) Meeting of the general body — The general body of the trust (D.S.T.) shall meet at least once in a year at such place as the executive committee may decide any special meeting of general body may be called whenever necessary.
- (c) Every member shall be entitled to receive invitation of meeting 15 days prior to the meeting day, but urgent meeting can be called on short notice.
- (d) Quorum — One quarter of total membership of the trust (D.S.T.) shall form the quorum of the general body of the trust (D.S.T.).

8. **Executive Committee :-**

- (a) The Executive Committee shall comprise of minimum 7 members including office bearer — (i) Chairman, (ii) Vice-chairman, (iii) Secretary & (iv) Four members.
- (b) Meetings — The Executive Committee shall meet at least twice a year at such time and place as Chairman may decide.
- (c) Every member shall be entitled to receive 7 days notice of any meeting of the Executive Committee.

- (d) Quorum — At any meeting 1/3<sup>rd</sup> as a minimum of four members of the Executive Committee shall from the quorum of the meeting.
- (e) Vacancies — Any vacancies arising among office bearers of the Executive Committee during their tenure of office shall be filled in by the Executive Committee from amongst the member of the trust (D.S.T.)
- (f) (i) All powers of administration management, supervision and initiation of programs shall vest in the executive committee. Whenever necessary the Executive Committee may delegate its power to office bearers of sub committees to initiate and execute programs. The Executive Committee is empowered to make its own by-laws.
- (ii) Tenures of Office — The present Executive Committee shall be in office for a term of five years. In accordance with the provision of there rules at the general body meeting, the term of the Executive Committees would however automatically intend till the next election takes place. All members of the Executive Committee would be eligible for reelection.

9. **Duties of Office Bearers :-**

- (a) The Chairman :- The Chairman of the trust shall be the Chairman of all the meetings of the trust and would be over all in charge of the trust (D.S.T.)
- (b) Vice-chairman :- In the absence of the Chairman the Vice-chairman shall preside over the meetings and perform such other duties which are performed by the Chairman.

(c) The duties of Secretary shall be :-

- (i) To implement administrator and carry out the approved programs and activities of the trust (D.S.T.). He will also be empowered to initiate and undertake programs whenever necessary.
- (ii) To keep records of the proceeding of all the meetings of the trust (D.S.T.) and necessary information pertaining to their activities.

- (iii) To carry on correspondence on behalf of the (D.S.T.) and to have the custody of the records and file of the trust (D.S.T.).
- (iv) To maintain regular accounts, proper periodical reports and statements of accounts of the trust (D.S.T.) to the Executive Committee and general body.
- (v) To borrow on the behalf of the trust (D.S.T.) after due authorization of the Executive Committee funds or loans financial and or lending institutions.
- (vi) Whenever necessary to undertake tour in the interest of the trust (D.S.T.)
- (vii) To receive and disburse amounts and incur expenditure as per approved budget.
- (viii) To be in charge and take care at all assets, equipments machinery ad building etc.
- (ix) The Secretary may delegate all or any of his powers and functions to any members of the trust (D.S.T.).

10. **Execution of Funds :-**

The funds of the trust will be deposited in the trust accounts in any nationalized bank. The bankers of the trust (D.S.T.) shall be decided by the Executive Committee. For withdrawal funds combined signature of Chairman or Vice-chairman and Secretary is necessary for any withdrawal from trust funds. In future Executive Committee may decide other signatory authority.

11. **Amendment of Constitution :-**

The constitution can be amended or altered at any general body meeting of the trust (D.S.T.) by two third of members present at such meetings.

12. **Funds :-**

The trust (D.S.T.) shall raise its funds from following sources :-

- (i) Membership fees.
- (ii) Grant from Central and State Governments.
- (iii) Grants, Contribution, Donation from Members, Non-members, Local bodies, National and International Fund Agencies etc.

13. **Audit :-**

The accounts of the trust (D.S.T.) shall be audited by a qualified Auditor or Auditors appointed by the general body.

14. **Legal Action :-**

All legal action will be used in the name of the Secretary of the trust (D.S.T.)

15. **Record :-**

All records such as membership and maintenance book, stock and cash book, ledger etc. will be in the custody of Secretary.

16. **Dissolution of the Trust (D.S.T.) :-**

(a) The trust may be dissolve by the decision of at least three fifth of the total member of the trust (D.S.T.) arrived at in a meeting or by obtaining the approval there of the required number by circulation to all members.

(b) On dissolution the trust (D.S.T.) if any property remains after satisfying all the debts and liabilities of the trust (D.S.T.) it shall not be divided among the members of general body as the Executive Committee but shall be transferred to same other trust having similar objective according to the provision of the registration of the trust act 1892 for the information our trust will do any social work with cash money mentioned in our deed.
